**PRODUCT DESCRIPTION:** Restoration Glass® is an authentic hand-crafted glass produced to replicate antique window glass of the 17th through early 20th centuries. This special glass is created in the original cylinder method and cannot be created with modern machine techniques. Restoration Glass exhibits a wavy appearance, occasional small bubbles, and subtle surface imperfections, which are inherent to the mouth-blown production process. It is available in two varieties, Full and Light, displaying two levels of distortion. "Full" Restoration Glass is more distorting, accurately replicating glass made in the 17th and 18th centuries. "Light" Restoration Glass is less distorting and is a perfect match for 19th and early 20th century structures. The slight distortion can be hard to distinguish when viewed up close; however, it becomes more pronounced when viewed from a distance and over a larger area.
